ndia marks the Pravasi Bharatiya Divas to commemorate the return of Mahatma Gandhi from South Africa on January 9, 1915. The day is celebrated every year on January 9, while every two years, on the same date, the government of India honours the tireless champions of the Indian diaspora — the women and men who, through grit, vision, and service, have not only made a mark on the global stage but also carried the essence of India in their hearts and work.

In 2025, 27 exceptional individuals and organizations from around the world have been conferred with the Pravasi Bharativa Samman Award (PBSA)—the highest recognition bestowed by the Government of India on overseas Indians.

These laureates come from five

continents and 25 countries, representing a kaleidoscope of professions: from medicine to politics, education to enterprise, science to spiritual service. What unites them is their unwavering commitment to excellence, and their deep-rooted empathy for India and the Indian community worldwide.

Conferred by the President of India, the PBSA is not merely an award—it is a testament to the enduring bonds that Non-Resident Indians (NRIs) and Persons of Indian Origin (PIOs) share with their motherland. Whether advocating for India's causes on international platforms, advancing humanitarian efforts at the grassroots, or simply making the Indian identity a beacon of pride in foreign lands, each awardee has helped script India's global narrative.

This year's awardees include stalwarts like Prof. Ajay Rane from Australia. recognised for his contributions to community service in healthcare; Dr. Philomena Mohini Harris from Barbados. whose pioneering work in medical science continues to inspire; and Baroness Usha Kumari Prashar from the UK, whose political and public service have uplifted countless lives while strengthening Indo-British ties. From Dr. Lekh Raj Juneja's scientific strides in Japan, to Atul Arvind Temurnikar's educational reforms in Singapore, to the grassroots impact of Hindustani Samaj in Russia—every recipient embodies the spirit of Seva (service), Samarpan (dedication), and Sankalp (resolve).

Equally remarkable are the awardees

whose contributions lie in often overlooked sectors—like Soukthavy Chowdhury in Laos, promoting Indian entrepreneurship in emerging economies, or Bonthala Ramesh Babu in Uganda, whose community work has uplifted marginalised Indian-origin population, Others, like Dr. Kaushik Ramaiya in Tanzania or Ravi Kumar in the United States, combine professional brilliance with a philanthropic drive that transcends borders.

Since its inception in 2003, the PBSA has stood as a beacon of India's gratitude to its global citizens. These awards, presented at the biennial Pravasi Bharativa Divas Convention, are more than symbolic—they are affirmations of India's trust in its diaspora, and recognition of the transformative power that overseas Indians wield in shaping

VISIONARY ENTREPRENE UR, DEDICATED LEADER AND A PILLAR OF COMMUNITY SERVICE

From humble beginnings to regional leadership, Bonthala Subbaiah Setty Ramesh Babu's legacy unites business acumen and heartfelt service—empowering communities, shaping industries, and forging bonds across cultures

onthala Subbaiah Setty Ramesh Babu stands out as an exemplary leader whose journey from humble beginnings to regional prominence encapsulates resilience, vision, and altruism. With roots in India and a farreaching impact in East Africa, his story reflects both professional excellence and a profound dedication to social good.

Ramesh Babu's educational foundations laid the groundwork for his diverse and illustrious career. After earning a Bachelor of Commerce from Bangalore University, India, in 1978, he pursued further specialisation, attaining his Fellowship (FCMA) from the Institute of Cost & Management Accountants of India in 1987. These qualifications equipped him with technical expertise, financial acumen, and the strategic insight that would become hallmarks of his future leadership.

His professional journey began in India, as he stepped into the public sector as an Accounts Officer at NTPC Ltd in 1989. NTPC, the country's premier thermal power corporation, values precision, transparency, and ethical

stewardship—qualities Ramesh Babu quickly adopted. His early exposure to a large-scale, government-regulated enterprise instilled an enduring respect for compliance and public accountability.

Not one to remain confined by boundaries, Ramesh Babu seized international opportunities. In 1990, he joined Athi River Mining in Kenya as Chief Financial Officer, overseeing the mining of industrial chemicals and marble.

Here, he sharpened his managerial skills as he dealt with the complex challenges of cross-border operation and regulatory requirements. His stewardship of accounts and finance extended the company's reach and set new benchmarks for efficiency and transparency.

From 1993 to 1995, he embraced the role of CFO at Kiboko Enterprises Limited in Uganda, a leading distributor of FMCGs and consumer durables. His work laid the foundation for sustainable financial practices within a rapidly expanding consumer market. Ramesh Babu's reputation as a transformative leader grew steadily.

"Success means nothing if it is not

Ramesh Babu's leadership reached its zenith when he became Managing Director and Shareholder of Kiboko & Abacus Pharma in 1995. Under his stewardship, Kiboko Group evolved from a modest operation with just two employees into one of East Africa's leading conglomerates, employing three thousand employees in all 5countries -- Uganda, Rwanda, Burundi, Tanzania, and Kenya. Today, Kiboko Group is recognised not only for its business success but also for its role in enhancing Uganda's industrial capacity and cementing India-Uganda trade ties.

"I have always believed that ethical business practices are the key to sustainable success—this is the principle that guides every initiative at Kiboko Group," he tells Pravasi Samwad during an interaction.

Kiboko Group exemplifies diversification, with interests in

His efforts, ranging from providing essential medicines to underserved communities to funding educational initiatives and supporting women's empowerment, have set new standards for corporate social responsibility.

He believes in hard work and commitment to achieve difficult goals. "From two employees to a multisector enterprise across five countries, comprising 3,000 employees, our journey reflects the power of hard work, perseverance, and a commitment to uplift communities."

He has been instrumental in bridging gaps between communities and cultures. As President of the Hindu Swavamsevak Sangh in Uganda and Founder and Chairman of Sewa International Uganda, Ramesh Babu leads initiatives that foster harmony, cultural understanding, and collective progress between Indian

His lifelong commitment to social and economic development was formally recognized in 2025, when he received the Pravasi Bharatiya Samman Award (PBSA). Presented by the Hon'ble President of India, Droupadi Murmu, the award acknowledges his outstanding contributions to community service and economic progress in Uganda. The official citation commended his role as a bridgebuilder between nations, emphasizing his invaluable efforts to strengthen bilateral ties and promote social welfare.

Ramesh Babu's ethic of service extends into his family. His daughter, Rukmini Bonthala Babu, actively takes the legacy forward as Executive Director of Kiboko Group and Abacus Pharma. Her involvement as an Advisory Board Member with the international NGO African Women and Girls underscores the family's wider commitment to women's empowerment, social justice, and inclusive development.

Ramesh Babu's accomplishments transcend metrics and awards; they are deeply embedded in a philosophy of giving back and inspiring others. His journey is a beacon for the Indian diaspora in Africa, but also for anyone seeking to make an enduring, positive impact through

- Food & Beverages: KIBS Snacks and Spaghetti became trusted local brands.
- Paper & Packaging: Ventures in paper manufacturing boosted local production and reduced reliance on imports through his company Siti Industries.







n a world where fragrance is fleeting, Soukthavy Chowdhury has made it his legacy. A pioneering entrepreneur, visionary leader, and cultural bridgebuilder, Chowdhury's contributions in business and community development have not only redefined the economic landscape of Laos but have also strengthened the global footprint of Indian-origin entrepreneurship.

From transforming Laos's agarwood industry to creating the nation's first fragrance export brand, Chowdhury's journey is a masterclass in entrepreneurial vision.

As Chairman and Managing Director of the HSMM Group of Companies—which includes the Lao Agar Development Co. Ltd., HS International Sole Co. Ltd., HSMM Fragrance Co. Ltd., and HSMM Mining Ltd.—he has been a driving force in shaping the country's industrial growth for over two decades.

Starting his career with the HSMM Group in 2002, Chowdhury's forwardthinking leadership helped establish vast agarwood plantations, state-of-the-art processing units, and a strong marketing network spanning the Middle East, China, Korea, Japan, and beyond. What began as a professional journey soon became a mission to place Laos on the global map for premium natural products.

HSMM Fragrance: The Scent of National Pride

In 2020, Chowdhury launched HSMM Fragrance, Laos's first indigenous fragrance brand, uniquely blending agarwood oil and the essence of Dok Cham Pa, the national flower of Laos. The brand quickly gained international acclaim in markets such as Russia, South Africa, and the Middle East.

A landmark moment came during the 2024 ASEAN Summit in Vientiane, where Chowdhury introduced the signature perfume "Lao ASEAN"—a symbolic offering labeled "Product of Lao, Gift for ASEAN." It was a gesture that elevated the cultural diplomacy of Laos and reflected his deep commitment to promoting the country's heritage and enterprise.

In the United States, Ford has become a tireless advocate for Bengali and broader Indian traditions. Through education, cultural programmes, and interfaith dialogues, she has worked relentlessly to make Indian spirituality and values accessible to the Western audience.

As a senior member of ISKCON, she has played a key role in spiritual leadership, helping Indian-American youth remain connected to their roots while nurturing global appreciation for Vedic wisdom.

Building a Legacy of Service



From distant lands to wedding bands

Tips for NRIs to marry abroad

• Residing abroad, Indian embassies can solemnise marriages of citizens residing abroad

 There are set norms for NRI marriages abroad in which one party is an NRI andother is non-Indian or both are NRIs

recent case of an Indian boy marrying Moroccan girl grabbed media attention in India and abroad. The boy, Avinash Dohre from the Indian city of Gwalior in Madhya Pradesh, met the girl, Fadwa Laimali from Morocco on a social media platform. After three years of trying to convince parents from both sides and clearing legal complications, Avinash and Fadwa got married under the Common Marriage Act in front of an Additional District Magistrate in Gwalior on January 2022.

Even though Avinash does not come under Non-Resident Indian (NRI) category, due to his Indian resident status, there must have been certain legal requirements which would have involved the Indian Mission in Morocco to get a go ahead for the marriage. Had Avinash been an NRI residing in a country other than India, the procedures would have been different.

It is pertinent in this background to understand the legalities of marriages being performed in other countries in which one party is an NRI and other is a non-Indian or both are NRIs.

REGISTRATION AND SOLEMNISATION OF MARRIAGE

Under the Foreign Marriage Act, 1969, an Embassy is authorized to solemnise marriages of citizens of India residing abroad.

A. Following are the requirements when one partner is Indian, and the other partner is a foreigner:

An advertisement in a local newspaper in the country of residence and one advertisement in an English newspaper at the native place in India in respect of Indian partner and advertisement in an English newspaper of the foreign country (in case one of the parties is a foreigner), announcing their intention to marry and that if anyone has any objection to the marriage, he/she may contact the Embassy of India. Original clippings of these newspapers are to be submitted to the Embassy.

A letter from the Embassy of the country to which the foreign partner belongs, stating that the Embassy does not have any objection to the marriage of its national.

B. Following are the requirements when both the partners are Indian

An advertisement in the newspapers (both in English and in the native language) in India widely read in the hometown of the partners, giving the name/address and other particulars of the boy/ girl, announcing their intention to marry and that if anyone has any objection to the marriage, he/she may contact an Embassy of India. A similar advertisement is also to be got published in one country of residence (foreign country) newspaper, which is widely read, on the same lines. Original clippings of these newspapers are to be submitted at the Embassy.

Photocopies of passports and IDs of both partners and three witnesses. Copies of identity documents (reflecting their addresses) of parents of the groom

5 names, addresses and copies of identity document **7** Photocopies of the passports, identity documents of parents of groom and bride. Passport copies and ID copies of three witnesses in the country of residence.

Passport copies, ID copies of country of residence and five Tpassport size recent colour photographs in respect of each partner.

The singleness/bachelorhood certificate from India should be duly attested by the Ministry of External Affairs, Govt. of India.

Marriage declaration form (Form8B.pdf | Form8B.docx) to be submitted to the Consular Officer, duly signed by the partners. The Form is to be signed before the Consular Officer who would attest the

Marriage fee is to be deposited at the time of submission of the Notice of Intended Marriage(Form8C.pdf |Form8C.docx), and the other documents listed at number 1 to 5 above, at least thirty days prior to the proposed date of marriage.


Marriage declaration form (Form8B.pdf | Form8B.docx) to be submitted to the Consular Officer, duly signed by the partners. The form is to be signed before the Consular Officer who would attest the same.


Marriage fees is to be deposited at the time of submission of the notice of intended marriage(Form8C.pdf |Form8C.docx) and the other documents listed at number 1 to 5 above, at least thirty days prior to the proposed date of marriage.

Note: An additional surcharge (depending on country's Indian Embassy) is levied on each Consular service as contribution towards the Indian Community Welfare Fund (ICWF).

• Marriage registration is subject to approval of the documents by the competent authority

Thus, anyone planning marriage while living away from India as an NRI should keep a checklist ready to

"If the NRIs are given a sense of community and attachment from the Indian embassies abroad, it will help them. Having regular cultural events for NRIs will be a good step."

"I was deeply humbled to be felicitated by the Indian Ambassador during the Republic Day flag-hoisting ceremony in recognition of the Pravasi Bharatiya Samman Award. Several

social organisations in Riyadh have also honoured the achievement with special felicitation events."

He has been touched by the emotional response of folks back in his hometown of Gulbarga where preparations were underway for a grand reception. He happens to be the first recipient of this PBSA award from Karnataka.

rom the rich cultural soil of Punjab to the distinguished chambers of the Spanish Senate, Robert Masih Nahar's journey is a glowing testimony to the transformative power of determination, cultural pride, and social service.

Honoured with many awards, Nahar has seamlessly integrated his Indian heritage with that of his adopted homeland, Spain—setting an inspiring example for diasporic leadership.

Early Life and Migration

Born on September 5, 1974, in Gurdaspur, Punjab, Nahar graduated with a degree in Chemistry. His pursuit of broader horizons led him to Mexico and Italy, before he settled down in Barcelona, in 2005.

There, he immersed himself in grassroots work—eventually becoming a vital voice for immigrant integration and cultural preservation.

A Pioneer in Politics

In 2017, Nahar created history by becoming the first Asian parliamentarian of Indian origin in the Spanish Senate, representing the Republican Left of Catalonia (ERC).

Elected twice, he used the platform to champion the rights of immigrants,

promote multicultural dialogue, and advance sports and youth development.

His political career was shaped by grassroots involvement, including his nomination as a city councillor in the 2015 Barcelona elections.

Community Crusader During Crisis

When the Covid-19 pandemic struck, Nahar responded with compassion and urgency. He launched the Food Solidarity Programme in Barcelona, which delivered more than 200,000 kg of food to 45,000 vulnerable individuals. His humanitarian response earned him widespread respect and admiration.

Cultural Catalyst and Cricket Evangelist

Recognising the power of sports as a social unifier, Nahar pioneered the growth of cricket in Catalonia. He founded the Catalonia Cricket Club, the Union of Catalan Sport Cricket Clubs, and the Catalan Cricket Federation, now with over 93 affiliated clubs. His initiatives turned cricket into a thriving medium for youth engagement and cultural exchange in Spain.

Simultaneously, his commitment to cultural preservation led him to co-found the Indian Culture Center in Barcelona and the Indali Foundation. He translated official Catalan learning material into Punjabi to help new Indian immigrants navigate life in Catalonia—efforts he is

now extending into Hindi and Punjabi translations of beginners' Spanish guides.

Diplomatic Bridge and Global Indian

Nahar's dual identity has allowed him to serve as a dynamic bridge between India and Spain. From championing Indian arts and languages to promoting bilateral trade and education linkages, he has become a key figure in shaping Indo-Spanish relations. His work has also addressed issues such as turban restrictions, identity documentation, and family reunification for the Asian community in Spain.

Global Recognition and Vision

In 2025, Nahar's lifelong dedication was nationally recognised when President Droupadi Murmu conferred upon him the Pravasi Bharatiya Samman Award, India's highest honour for overseas Indians. He became the first person from Spain to receive this distinction—marking a historic moment for both nations.

In his reflections shared with Pravasi Samwad, Nahar credits Prime Minister Narendra Modi's global diplomacy for raising India's stature, which, in turn, has empowered the diaspora. He sees himself not just as a beneficiary of this new perception but as an active contributor serving as a cultural ambassador, policy advocate, and humanitarian activist.

"Vasudhaiva Kutumbakam – the world is one family – is not just a philosophy I believe in; it's one I live every day," he says

while commenting on his purpose of life.

Looking ahead, Nahar aspires to unify the Indian diaspora across Europe, foster deeper engagement with India's development, and potentially serve Bharat, his "Janmabhoomi", in an official capacity—completing a circle of service that began with one man's dream in Punjab.

Nahar finds a positive perception about India on the global stage. "It has secured a central place on the global stage. In trade and commerce, we are a vital partner; in knowledge and innovation, a trusted collaborator; and in navigating complex geopolitics, a decisive force."

"As a Pravasi Bharatiya, I have felt this transformation deeply. On one hand, PM Narendra Modi's message continues to inspire us—we are more driven than ever to contribute to India's progress with renewed passion and purpose. We carry the spirit of India with us and serve as global ambassadors of our nation's values, culture, and aspirations," he says.

He is a firm believer in the fact that the Indians living abroad should be given a chance to take part in India's electoral

"In today's interconnected and globalised world, the international diaspora is not merely a passive observer but an active participant in the democratic processes of the countries in which they reside. In fact, in many nations, nonresident citizens are not only granted the

right to vote but are, in some cases, legally obligated to exercise it."

"Culturally, the Indian diaspora in Spain plays a vibrant and visible role. Numerous artists of Indian origin are proudly showcasing Indian art, music, dance, and literary heritage on prestigious platforms. As the founding president of the Indian Culture Center, I have had the privilege of supporting this creative expression and helping our community promote Indian languages, classical and contemporary arts, and cultural traditions within the broader Spanish and European contexts."

According to him. commerce and trade represent yet another area of dynamic engagement. The Indian diaspora in Spain plays a pivotal role in importing and promoting Indian products — ranging from food and clothing to technology and entertainment.

"These economic activities not only strengthen bilateral trade but also enhance India's soft power and cultural visibility abroad."

Need to Bridge Gap Between Homeland and Developed World

"As someone who has lived and worked closely with the Indian community across Europe, I've seen that whether we move abroad by choice or necessity, our hearts remain deeply connected to our motherland. I believe it's our collective responsibility as NRIs to contribute meaningfully to India's progress and help bridge the gap between our homeland and the developed world. I feel fortunate to have served Spain, my "karmabhoomi", as a senator twice, and I remain hopeful for a third term. But my commitment to Bharat, my "Janmabhoomi", is unwavering. It would be the greatest honour of my life to one day serve India and give back to the nation that shaped my identity." ■

Inflation impact: Calculate potential real returns by factoring in inflation rates to ensure that earnings outpace rising costs.

s the CEO and Consultant Physician at Shree Hindu Mandal Hospital in Dar es Salaam, Tanzania, Dr. Kaushik Laxmidas Ramaiya has become a pioneering force in noncommunicable disease (NCD) research and public healthcare leadership.

Dr. Ramaiya's influence spans continents, even as his mission has been tailored to advance healthcare equity and develop practical, research-backed solutions vis-a-vis Africa's unique

"Our work in Tanzania is grounded in science, but driven by compassion," he reflects. "Every study we conduct, every programme we initiate, is about improving lives—especially for communities that have long been underserved.'

His research into Type 1 diabetes in children, gestational diabetes, and the metabolic complications linked to antiretroviral therapy has impacted national policies and clinical protocols, reshaping how NCDs are diagnosed and managed in East Africa.

With over 100 peer-reviewed publications, Dr. Ramaiya's scientific contributions are referenced globally. His expertise has helped integrate NCD care into primary health systems across Tanzania—a monumental step toward sustainable healthcare reform.

Building Institutions, Empowering Communities

Under his leadership, Shree Hindu Mandal Hospital has

emerged as a premier centre for diabetes care and research. Dr. Ramaiya's impact, however, transcends institutional walls.

His collaborations with the Tanzanian Ministry of Health and the President's Office for Regional Administration and Local Government have enabled the rollout of nationwide NCD care programmes, reaching even the most remote populations.

"Real change happens when research meets action," he says. "I always say: "Publish less, implement more."

> A committed advocate for public health, Dr. Ramaiya serves on the board of the National Health Insurance Fund, contributing to reforms that enhance affordability and accessibility in healthcare delivery. His work exemplifies the

on-Resident Indians (NRIs) often find themselves managing finances acrossborders, necessitating a nuanced understanding of banking regulations andprocedures. In India, NRIs typically operate two types of bank accounts - NRE and NRO.

Understanding the basics: NRE vs. NRO accounts

- A fundamental difference between NRE (Non-Resident External) and NRO (Non-Resident Ordinary) accounts lies in the transferability of funds outside of India.
- NRIs are allowed to deposit their earnings from foreign sources in NRE account, while NRO account is an easy way for them to deposit their earnings generated inIndia.
- Money held in an NRE account can be readily transferred abroad, whereas thesame is not true for NRO accounts. Transferring funds from an NRO accountdemands adherence to specific document requirements, Reserve Bank of India(RBI) approvals, and annual limits.

Source of funds: Key determinant

The source of funds plays a pivotal role in determining the amount of money that can be remitted from an NRO account. According to financial experts, NRIs canremit up to USD 1 million per financial year from NRO account balances sourcedfrom non-current income. However, there is no limit on remitting current income, such as rent, dividend, pension, or interest, from NRO accounts.

When is RBI approval necessary?

RBI clearance is essential for remittances from NRO accounts, particularly when transferring funds exceeding USD 1 million in a financial year for non-currentincome. For current income, such as rent or interest, approval isnot required.

Banks, as authorised dealers, can facilitate these remittances, provided allnecessary documentation and requirements are met.

Understanding the complexities of NRO accounts, NRIs must remain vigilantabout regulatory requirements, tax obligations, and documentation procedures toensure seamless fund transfers across borders.

Tax implications and prerequisites

Before transferring funds from an NRO account, taxes must be settled in India, ifapplicable. Section 195 of the Income Tax Act mandates the submission of Form15CA and Form 15CB for outward remittances, with TDS applicable on taxableincome elements. However, no TDS is required for transfers between NRO and NRE accounts or to personal bank accounts outside India.

Documentary requirements

To initiate outward remittances from NRO accounts, NRIs must furnish severaldocuments, including applications, prescribed forms, CA certificates, declarations, PAN cards, and evidence of the source of funds. The specific documentation may vary depending on the nature and origin of the funds.

Submission process and timelines

Documents must be submitted to the respective bank, either electronically or inhard copy. Processing times for remittances vary depending on documentverification and bank procedures. Any additional queries or document requests from the bank may prolong the process.

Limit calculations and considerations

While there is no limit on the frequency of remittances from NRO accounts, thetotal amount remitted must not exceed USD 1 million per financial year for non-current income. Currency exchange rates and bank charges also influence the finalremittance amount.

Additional tips

NRIs should compare exchange rates and transaction charges offered by banks tooptimize remittance amounts. Making all remittances through a single bank orauthorized dealer can help track total remittance amounts and prevent exceedingthe USD 1 million limit.

RBI clearance is essential for remittances from NRO accounts, particularly when transferring funds exceeding USD 1 million in a financial year for non-currentincome.


"It was a time of crisis, and humanity had to rise above all I was just doing my duty as an Indian," he reflects.

India to Build Comprehensive Girmitiya Database: PM Modi Announces Global Initiative

n a landmark initiative to strengthen ties with its global diaspora, India has begun work on a comprehensive Girmitiya database. This ambitious project aims to document the villages and cities from which Girmitiya ancestors set sail, trace the countries where their descendants built new lives, and safeguard the community's rich cultural and historical legacy for future generations

Prime Minister Modi announced the initiative during his address to the Indianorigin community in Trinidad and Tobago.

PM Modi described the project as a way of strengthening not only identity but

also belonging. "We are mapping the past and bringing people closer for a bright future," he said.

The Prime Minister also shared that the database will serve as a foundation for organising World Girmitiya Conferences on a regular basis.

These gatherings, he said, will provide platforms for dialogue, cultural exchange, and the recognition of the Girmitiva journey across continents. "We are actively working on creating a comprehensive database of the Girmitiya community, studying and preserving the legacy of our ancestors, and supporting

our brothers and sisters in Trinidad and Tobago," he added.

In a historic gesture, PM Modi announced that people of Indian origin in Trinidad and Tobago—up to the sixth generation—will now be eligible for Overseas Citizen of India (OCI) cards.

children and neighbours. We will welcome all of you with open arms, warm hearts, and jalebi," he said, drawing applause and laughter from the audience.

They were not just migrants, they were messengers of a timeless civilisation," he remarked, paying tribute to their enduring cultural spirit.

"Now sending money will be as easy as sending a 'good morning' text message. And I promise, it will be faster than West Indies bowling," he quipped.


The ceremonial welcome at Piarco

झारखंड में जनजातीय समाज की सामूहिकता



एक्ट लोकली थिंक ग्लोबली का विकास मॉडल

झारखंड में जन्मा हुं। मैंने जनजातीय समाज और यहां के लोगों को नजदीक से देखा है। जनजातीय समाज हमारी सभ्यता का पोषक है, तो भारतीय संस्कृति का वाहक भी। उनकी भाषा, बोलचाल, रहने का तरीका उन्हें विरासत में मिले, तो उनके उनमूक्त विचार 'एक्ट लोकली, थिंक ग्लोबली' को चरितार्थ करते हैं। उन्हें भी पता नहीं होता कि वे जो काम स्थानीय स्तर पर कर रहे हैं, दूनिया भर में इसके लिए मुहिम छिड़ी हुई है। जैसे वे स्थानीय स्तर पर जंगल बचाने को मर मिटने को तैयार हैं, तो पूरी दुनिया में पर्यावरण के बचाव के लिए जंगल का विस्तार किया जा रहा है। जल, जंगल और जमीन से उनका लगाव यही दिखाता है कि वे अपने मूल से

कटना नहीं चाहते। इसी मूल में समाहित है उनकी सामूहिकता की जड़, जो उन्हें अपनों और समाज से जोड़े रखती है।

मुझे जमशेदपुर में एक साल रहने का मौका मिला। इस दौरान मैंने घाटशिला का कई बार भ्रमण किया। एक बार जब वहां के सुदूर गांव नागरा के मध्य विद्यालय में मध्याह्व भोजन में छिपकली गिरने की घटना (12 सितंबर 2008) हुई, तो मुझे इस समाज को नजदीक से समझने का अवसर मिला। मैंने पाया कि जनजातीय समाज सहनशील है, तो कई मौकों पर आक्रामक। सहनशीलता और आक्रामकता के बीच की कड़ी भी बनी तो उनकी सामूहिकता। उनके समूह में रहने की शक्ति ने उनके लाडलों का हक दिलाया। लेकिन एक कमजोरी दिखी तालमेल के अभाव में नेतृत्व क्षमता का खोना। उर है कि अपनी धुन में रहने वाले ये लोग चमक—दमक की

दुनिया को ही सच न मान बैठें। विकास से कदमताल करने के लिए अपनी सामूहिकता को ही न खो दें, जो समाज, देश और दुनिया के लिए विकास का आधार बन सकती है।

बदलाव के बयार में जनजातीय समाज ने खुद को विकास की उस परिभाषा से अलग रखा है, जिसके नाम पर संस्कृतियां अपनी जड़ों से कटती जा रही है। विकास के नाम पर इनसे जल, जंगल और जमीन से सौदा करने की कोशिश हो रही है। सबसे ज्यादा युवाओं को रिझाने के प्रयास किए जा रहे हैं। यही इनके संस्कारों के वाहक हैं। अशिक्षा, बेरोजगारी और सरकारी योजनाओं का लाम इन तक नहीं पहुंचने के कारण इनकी कमजोरी का फायदा उठाया जा रहा है। ऐसे हालात पैदा किए जा रहे हैं कि जनजातीय समाज उस दिशा में घूम जाए जो व्यक्तिगत लाम के पीछे दौड़े। जनजातीय समाज की अवधारणा को नजरअंदाज कर विकास की उस अंधी दौड़ में शामिल हो जाए जो उन्हें अपनेपन के स्वभाव से दूर कर दे। सामूहिकता के नाम पर संबंध विच्छेद का ऐसा खेल चल रहा है कि अन्य समाज को ये अपने से इतर समझ बैठे हैं।

जनजातीय समाज की सामृहिकता कैसे बरकरार रहे, पीढ़ियों से इस समाज ने कैसे अपनी संस्कृति और संस्कार संजोए रखा और यह अन्य समाज के लिए कैसे आदर्श बनकर, खासकर उनकी सामृहिकता विकास की रुपरेखा खींच सकती है. इनपर मैंने शोध के माध्यम से जानने का प्रयास किया। यह जाना कि आदिवासी समाज की सामूहिकता का आखिर आधार क्या है। इनमें इसका संचार पीढ़ी दर पीढ़ी कैसे हो रहा है? इसके संवाहक खुद को आज तक कैसे बचाए रखे हैं? इनकी सोच पर इनकी संस्कृति और संस्कारों का कितना जोर रहता है? अगर इन्होंने संसाधनों के अभाव में भी सामूहिकता के बल पर अन्य समुदायों को प्रेरित किया, तो क्या आज के दौर में विकास का मॉडल नहीं बन सकते?

शोध अध्ययन में पाया कि जनजातीय समाज की सारी गतिविधियां मानवीय दृष्टिकोण के आधार पर संचालित हैं। लेकिन यह अप्रत्यक्ष रूप से हैं। यही कारण है कि उनकी सामूहिकता प्रत्यक्ष होती हुई भी दिख नहीं पाती। जनजातियों को अपनी परंपरा, संस्कृति और विरासत खोने का अहसास नहीं हो पाता। मेरे शोध का निष्कर्ष एक कोशिश रही कि कैसे जनजातीय समाज एकजुट रहे, क्योंकि झारखंड के विकास का पर्याय इन्हें ही बनना है।

की सामूहिकता विकास का मॉडल == पर शोध कार्य के लिए भारत सरकार की जनगण ाना रिपोर्ट का विशेष अध्ययन किया। इसके आधार पर जनजातीय समाज की सोच, सच्चाई और सामूहिकता के तह में जाने का प्रयास किया। अध्ययन के बाद जमीनी हकीकत के लिए साक्षात्कार का विषय चुना। इसके लिए एक प्रश्नावली तैयार की, जिसमें उनके परिवेश, बदलते माहौल और इसका जनजातीय समाज पर असर से संबंधित सवालों पर बल दिया गया। उनके जवाब और पूर्व के अध्ययनों को विशलेषण कर रिपोर्ट तैयार की गई।

रिपोर्ट के लिए मिले तथ्यों और आंकड़ों के आधार पर यह कहा जा सकता है कि जनजातीय समाज की पारंपरिक सोच विकास में रोड़ा नहीं डालती। वह जल, जंगल, जमीन की सुरक्षा और संरक्षा के साथ आगे बढ़ना चाहता है। सरकार से कई अपेक्षाएं हैं, लेकिन योजनाओं का लाभ नहीं मिलने के बावजूद लगातार आगे बढ़ता जा रहा है। शोध के दौरान निम्न बातें उभर कर सामने आईं–

- 1. जनजातियों के संदर्भ में अन्य समुदाय आज भी उनके प्रति पूर्वाग्रह से ग्रसित है कि वे विकास से कदमताल में पीछे हैं। जबकि रिपोर्ट बताती है कि उनके सभी क्रियाकलाप और गतिविधियों में सामूहिकता का सार छुपा है, जो उन्हें आगे बढ़ने का संदेश देती है।
- 2. सरकारी योजनाओं का लाभ इन्हें पूरी तरह नहीं मिल रहा है। खासकर उनकी संस्कृति, भाषा, मेला, संस्कार आदि को बचाने के प्रयास नहीं किए जा रहे।
- 3. जनजातीय महिलाओं के लिए कोई ऐसी संस्था नहीं मिली, जो उनकी बातों को प्रमुखता से किसी खास मंच पर रख सके।
- 4. जनजातीय युवाओं में बदलाव का दौर दिख रहा है, पर वे अपनी संस्कृति और परंपरा से कटना नहीं चाहते।
- 5. उनकी सामूहिकता कम हो रही है, क्योंकि अब ऐसे सभी आयोजन कम हो गए हैं जहां वे लोग सामूहिक रूप से मिलते थे। सरकार का पक्ष भी यहां कमजोर हुआ है। वो भी सूदूर गांवों में ऐसा आयोजन कराने में नाकाम हुई है।
- 6. अब इनके गीत—नृत्य की नई रचना लगभग थम सी गई है। नई रचनाओं ने व्यावसायिक रूप ले लिया है, जिसमें सामूहिकता, सामाजिकता, श्रमशीलता आदि गौण है।

भारत की वैश्विक पहुंच के ध्वजवाहक प्रवासी भारतीय

करी के अवसर और जीवन की बेहतरी के लिए भारत की बड़ी आबादी परदेस की राह पकड़ रही है। विदेशों में लाखों की संख्या में प्रवासी भारतीयों को काम के अच्छे अवसर और अच्छे पैसे मिल रहे हैं। इनमें से एक महत्वपूर्ण संख्या खाड़ी देशों में भी रहती है। पर कहते हैं ना कि दूर देश में भी अपने गांव-शहर, घर-परिवार-समाज की चिंता और यादें पीछा नहीं छोड़तीं। शायद ऐसे ही ख्यालों को लेकर ही राही मासूम रजा साहब ने लिखा होगा.

हम तो हैं परदेश में देश में निकला होगा चांद अपनी शत की छत पर कितना तन्हा होगा चांदा

आसमान दूर देश का हो तो भी चांद तो अपने देस का ही नजर आता है। इन पंक्तियों की डोर थामे ना जाने कितनों ने यादों के गलियारों में तफरीह कर सोचा होगा. उनके बिना किस हाल में होगा चांद। और यही सोच उन्हें अपने देस से जोड़े रखती है। प्रवासी भारतीय धनप्रेषण, व्यापार, निवेश और विदेशी मद्रा भंडार में योगदान देकर भारत की अर्थव्यवस्था में महत्वपूर्ण भूमिका निभाते हैं। वे भारत और मेजबान देशों के बीच सांस्कृतिक अंतर को पाटने तथा संचार को सुविधाजनक बनाने में भी अहम किरदार निभातें हैं।

क्यों अहम हैं प्रवासी

सबसे बडा प्रवासी समदाय

विदेशों में निवास करनेवाले भारतीय मल के लोग प्रवासी भारतीय हैं। इनमें अनिवासी भारतीय (एनआरआई) और भारतीय मूल (पीआईओ) दोनों शामिल हैं। अनिवासी भारतीय वैसे नागरिक हैं जो काम, शिक्षा या अन्य उद्देश्य के लिये अस्थायी रूप से विदेश में रहते हैं। भारतीय मूल के व्यक्ति का आशय वैसे भारतवंशी विदेशी नागरिकों से है, जो पीढ़ियों से विदेश में रहते हुए भारत के साथ सांस्कृतिक संबंध कायम रखे हैं।

विदेश मंत्रालय की नवंबर 2024 की रिपोर्ट के अनुसार, दुनियाभर में प्रवासी भारतीयों की संख्या लगभग 3.54 करोड़ है। इसमें लगभग 1.58 करोड़ अनिवासी भारतीय (एनआरआई) और 1.95 करोड़ भारतीय मूल के व्यक्ति (पीआईओ) हैं। हर साल लगभग 25 लाख भारतीय विदेश प्रवास करते हैं। सबसे बड़ी भारतीय प्रवासी आबादी वाले शीर्ष तीन देश

अमेरिका (54 लाख), संयुक्त अरब अमीरात (38 लाख) और मलेशियाँ (29 लाख) हैं। दिसंबर 2024 में लोकसभा में एक प्रश्न के उत्तर में सरकार ने बताया था कि खाडी सहयोग परिषद (जीसीसी) देशों में 93 लाख भारतीय रहते हैं। इनमें संयुक्त अरब अमीरात में 38.90 लाख, सऊदी अरब में 26.45 लाख, कृवैत में 10.09 लाख, कतर में 8.30 लाख, ओमान में 6.64 लाख, बहरीन में 3.32 लाख प्रवासी भारतीय हैं। भारत का यह प्रवासी समुदाय दुनिया के सौ से भी ज्यादा देशों तक फैला है। आंकड़ों की नजर से विश्व में सबसे बड़ा प्रवासी समुदाय अब भारतीय है।

धनप्राण में अव्वल

भारत के भविष्य को आकार देने में भी प्रवासी समुदाय की भूमिका महत्वपूर्ण है। इसमें अहम कड़ी प्रवासियों के भारत में रह रहे परिवार, मित्र या रिश्तेदारों को ध ान हस्तांतरण या धनप्रेषण (रेमिटेंस) की है। इससे गरीबी उन्मूलन, शिक्षा के लिए धन तथा बुनियादी ढाँचे को समर्थन देने में मदद मिलती है। विशेष रूप से केरल और पंजाब जैसे राज्यों में। वर्ष 2024 में भारत को 129. 1 अरब डॉलर का धनप्रेषण प्राप्त हुआ। यह किसी भी देश को एक वर्ष में मिला सबसे अधिक धन है। यह वैश्विक धनप्रेषण का 14.3 फीसदी हिस्सा था। अन्य देशों में दूसरे नंबर पर मेक्सिको (68 अरब डॉलर), फिर चीन (48 अरब डॉलर), फिलीपींस (40 अरब डॉलर) और पाकिस्तान (33 अरब डॉलर) थे।

आज भारत के सकल घरेल उत्पाद में ध ानप्रेषण की हिस्सेदारी लगभग 3.3 प्रतिशत हो गई है। इस धनराशि का इस्तेमाल स्थानीय अर्थव्यवस्था में उपभोग, व्यय और निवेश में होता है। भारतीय उद्यमों को वैश्विक बाजारों से जोडकर प्रवासी देश के व्यापार परिदश्य को समृद्ध बना रहे हैं। भारत को भेजा जानेवाले ध ान घरेलू आय, आर्थिक स्थिरता तथा समग्र विकास में महत्वपूर्ण योगदान देता है। विदेशों, खासकर खाड़ी देशों से, भारतीयों द्वारा भेजी गई धनराशि देश के विदेशी मुद्रा भंडार में महत्वपूर्ण योगदान देती है। 2024 में कुल ६ ानप्रेषण में से 38 प्रतिशत हिस्सा जीसीसी देशों से प्राप्त हुआ था।

उघमिता और नवाचार

प्रवासी समुदाय भारत के साथ दुनिया के भविष्य को आकार दे रहा है। वहीं, व्यवसायों में निवेश कर या अपने ज्ञान और विशेषज्ञता से भारत में नवाचार (इनोवेशन) और तकनीकी उन्नति में योगदान दे रहा है इससे आईटी, शिक्षा, स्वास्थ्य सेवा और ग्रामीण

विकास के क्षेत्र समृद्ध बन रहे हैं। प्रवासी भारतीयों ने विभिन्न क्षेत्रों में उल्लेखनीय योगदान दिया है। प्रौद्योगिकी और नवाचार में श्रेष्ठता का प्रमाण वैश्विक आईटी कंपनियां जैसे अल्फाबेट-माइक्रोसॉफ्ट में भारतीय मूल के इंजीनियरों का दबदबा है। स्वास्थ्य सेवा क्षेत्र की बात करें तो भारतीय डॉक्टर, नर्स और स्वास्थ्य कार्यकर्ता अमेरिका, युके, खाड़ी तथा अफ्रीकी देशों के चिकित्सा कार्यबल का अहम हिस्सा बनकर उभरे हैं।

वित्तीय परिसंचालन के क्षेत्र में देखें तो विश्व बैंक समूह के अध्यक्ष अजय बंगा हैं। विज्ञान के क्षेत्र में भारतीय मूल के वैज्ञानिक नोबेल परस्कार से सम्मानित रामकृष्ण ान वेंकटरमन हैं। सर्वाधि ाक प्रभावी क्षेत्र राजनीति और शासन के हैं। अमेरिका की पर्व उप-राष्ट्रपति कमला हैरिस, युके के पूर्व प्रधानमंत्री ऋषि सुनक जैसे उच्च पदस्थ भारतीय मल के राजनेता अपने प्रवासी देश की नीतियों को आकार तथा द्विपक्षीय संबंधों को बढावा दे रहे हैं। वहीं, डोनाल्ड टंप सरकार में भी प्रमुख पदों पर कई भारतीय मूल के लोग हैं। इनमें विवेक रामास्वामी, काश पटेल, जय भट्टाचार्या, श्रीराम कृष्णन, हरमीत ढिल्लों और ऊषा वांस प्रमुख हैं।

लेकिन प्रवासी भारतीयों की कहानियां केवल व्यक्तिगत उपलब्धियों के साथ समाप्त नहीं होतीं, उनका दायरा कहीं आगे का है। यह साझा जड़ों, आपसी विकास और बेहतर भविष्य की दृष्टि की कहानी है। आज जब दुनिया के देश एक-दूसरे के नजदीक आ रही है, प्रवासी भारतीय वैश्विक समुदाय और भारत के बीच सेतु का काम कर रहें हैं। इनका सामाजिक, सांस्कृतिक या आर्थिक योगदान विश्व मंच पर भारत की छवि को सशक्त और प्रभावी बना रहा है।
